Short description (max 100 words): AZ_OFF_EM_Recreational_ICCAT aiming to collect catch data from recreational fishing (spearfishing and recreational boat fishing) (highly migratory ICCAT species) as indicated in Table 4 of the EU MAP Delegated Decision annex.
Description of the population
Population targeted: The target population are recreational fishing boats, spearfishing. Population sampled: The licensed recreational fishing boat owners and spearfishers. Shore angling and hand collecting were not covered since do not catch the target species, thus are outside the scope of the survey. Stratification: For the AZ_OFF_EM_LicenseSyst_ICCAT, the frame population (license holders) was stratified into subpopulations strata (fishing mode, island, year). A subsampled (from license holders) is pull off and engage in the AZ OFF EM Recreational survey ICCAT.
Sampling design and protocols
Sampling design description: In the Azores, the recreational fishing multispecies survey will focus on the catch estimation for the species (highly migratory ICCAT species) as indicated in Table 4 of the EU MAP Delegated Decision annex performed by two recreational fishing modes (boat fishing and spearfishing). The methodology will be based on an off-site survey. The AZ_OFF_EM_Recreational_ICCAT survey aims to get a subsample from license holders. To recruit a panel for the logbook is used has the main engagement method the invitation of the recreational fishers within the survey of the license system platform (AZ_OFF_EM_LicenseSyst_ICCAT). It consists of a new user-friendly “Pescador” system (IOS/Android App and web-based) that allows collecting data on fishing effort, catch, releases and economic expenditures. Even though, the new “Pescador” system will be target of continuous development during 2025 - 2027, integrating new functionalities and tools (e.g., catch photos upload, complete trips validation tool). The old system e-form SRAF will work temporarily until all users start using the new Pescador system. The panel target of a quarter basis follow-up phone and e-mail contacts, to validate the complete 12-month fishing effort and catch information. Fishers without informatic competence will enter in the panel but surveyed by phone at a monthly basis. Is the sampling design compliant with the 4S principle?: NA. Regional coordination: N.

Monitoring of sampling progress within the sampling year:

Follow-up mechanisms by e-mail and phone are established monthly basis in AZ_OFF_EM_Recreational_ICCAT (including to record cases of drop-ins and drop-outs). The monitorization of data entering is made at daily basis. The monitoring system drive to detection of unusual level of refusals, informatics problems which trigger processes to analyse and find resolution.

Data capture**Means of data capture:**

Dedicated software (IOS/Android App and web-based) Pescador system was developed to collect data for recreational fishing (spearfishing and boat fishing). Even though, the new system “Pescador” will need continuous development and improvement during 2024, integrating new functionalities and tools (e.g., catch photos upload, complete trips validation tool). For AZ_OFF_EM_Recreational_ICCAT survey the panel is mainly recruited within the license system survey. The old system e-form SRAF is still operational, since some users still use it, but will be disabled during 2025 - 2027. The panel target of a quarter basis follow-up phone and e-mail contacts in order to validate the complete 12-month fishing effort and catch information.

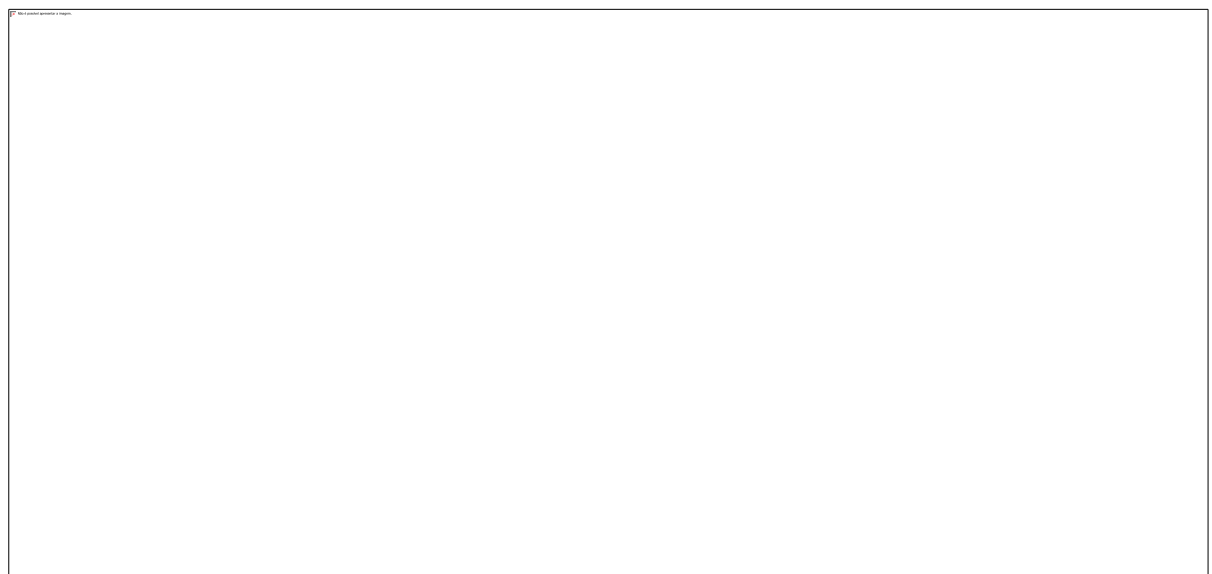


Figure 1. Web and APP Pescador system catch and effort data collection for recreational fishing (spearfishing and recreational boat fishing) (in Portuguese, Spanish and English language).

The precision estimators will be presented in an internal report in 2025 - 2027.
